**NOTES:**

**1. Membership Categories**

**Membership fees are due on 1<sup>st</sup> October each year**

**FULL MEMBER:** Annual subscription provides the full range of benefits of membership – including membership of BBKA and YBKA; entitled to vote at all meetings of same; insured for 3<sup>rd</sup> party liability; receive newsletters from BBKA, YBKA and ourselves (“Combings” is our quarterly in-house magazine)

**PARTNER MEMBER:** Must live at same address as Full member. Receives same benefits with the exception of “Combings”

**JUNIOR MEMBER:** Category is for anyone under 18 years of age – same benefits as Full Member. Insurance is via a nominated Parent/Guardian. If Parent/Guardian is a Full Member, then Junior should apply as a Social member

**SOCIAL MEMBER:** Registered with YDBKA only. Entitled to vote at YDBKA meetings and receives “Combings”

**2. GIFT AID**

This scheme allows YDBKA (being Registered Charity number 1177037) to recover tax paid on a gift from HM Customs & Revenue (HMRC). **THERE IS NO FURTHER COST TO YOU.** We make an annual application to HMRC and they pay the refund to us by bank transfer. This is a significant extra income for us, at very little effort beyond completing the appropriate HMRC paperwork, so we hope that all those who are eligible will sign up to the scheme. Please note that subscriptions paid for another person (such as a birthday gift) or those paid for by a business or other 3<sup>rd</sup> party are not eligible for the Gift Aid scheme. Subscriptions paid out of a joint account by one party will be eligible for all other joint account holders if they sign the declaration.

**3. How to pay your fees**

Fees are payable in sterling, and may be paid by cash, cheque or bank transfer – but however they are paid, you must complete and send your application form fully completed to the Membership Secretary. **Failure to submit your form will result in a delay to your renewal or new application, and you will not have the benefit of insurance cover until you have submitted your form.**
